

General Information Disclaimer Regarding Mobile IV Services

Thank you for choosing Mobile IV to provide you with our medically designed rehydration and rejuvenation therapy. It is our goal to provide you with the best treatment in a safe and comfortable manner. Our elective therapies are specifically designed to promote the feeling of health and wellness while treating symptoms of dehydration and fatigue.

It is important for you to know that the vast majority of patients receiving our therapy feel an improvement; however, every individual is different and there is no guarantee that you will feel better, nor does improvement of symptoms exclude other coexisting potential medical conditions.

It is also important to know that we offer no diagnostic testing, make no medical diagnoses, and reserve the right to refuse treatment to any patients deemed unstable or unsuitable, or whose symptoms are not consistent with the indications for Mobile IV therapies. Anyone who is intoxicated and is not able to demonstrate their clinical sobriety in order to consent for elective medical treatments will also be refused treatment.

A licensed health care professionals (Nurse Practitioner), who has contracted with Mobile IV, will perform the required health care service for you. The health care professionals which you establish a treatment relationship (Registered Nurse) is solely responsible for providing you with medical service.

To ensure maximum safety and comfort, we have a series of protocols to identify higher risk patients who may require and benefit from a higher level of medical care. Please take the appropriate time to (i) complete the attached medical screening questionnaire in detail; (ii) read and execute the attached waiver; and (iii) to discuss any questions or concerns you may have with our knowledgeable medical team prior to providing your consent.



This service is only available to individual who are 18 years and older. If you are under the age of 18 do not use our service.

Finally, we strongly recommend that if you feel unwell and your symptoms are not related to dehydration and fatigue you should immediately seek medical care. We also recommend that you seek medical advice in the event that you do not feel better following an infusion.

Misrepresentation:

If during book service process, you mis represent yourself in any manner, including but not limited to, misrepresentation of you age or medical history, Mobile IV has the right to cancel your booked service without notice and charge you the full amount. If at the time of your booked service, you are under the influence of drug or alcohol, Mobile IV will not preform the service and you will be charged full amount.

Refund:

In the event that the medical professional is unable to perform the booked services due to circumstances outside of the patient control our for reason other than the patient medical condition or health, you will receive a full refund.

In the event that the medical professionals is unable to preform the booked services due to (i) your current our previous medical history, condition, or reason, or (ii) due to circumstances outside medical professional control after the insertion of Mobile IV needle, you will receive a refund less the medical examination fee of (\$100.00) one hundred dollars.
